1. Striking numbers

Every day in the UK

- The population of the UK grew by an estimated 1,286 people a day between 2014 and 2015.
- On average, a UK household spends £3.40 a day on water, electricity and gas.
- 247 people a day are declared insolvent or bankrupt. This is equivalent to one person every 5
 minutes 50 seconds.
- 34 million plastic card purchase transactions were made every day in May 2016, with a total value of £1.57 billion.
- 8.5m cash machine transactions were made every day in April with a value of £344m.
- 2,102 Consumer County Court Judgments (CCJs) are issued every day, with an average value of £2,030.
- Citizens Advice Bureaux in England and Wales dealt with 4,495 new debt problems every day during the quarter ending March 2016.
- 18 properties are repossessed every day, or one every 1 hour and 19 minutes.
- The number of mortgages with arrears of over 2.5% of the remaining balance fell by 41 a day.
- The number of people unemployed for over 12 months fell by 301 per day between March and May.
- 1,130 people a day reported they had become redundant between March and May.
- Net lending to individuals in the UK increased by £173 million a day.
- The Government borrowed £260m a day during April 2016 (£3,009 per second).
- Borrowers would repay £144m a day in interest over a year, based on June 2016 trends.
- It costs an average of £30.23 per day to raise a child from birth to the age of 21.
- 53 mortgage possession claims and 36 mortgage possession orders are made every day.
- 398 landlord possession claims and 309 landlord possession orders are made every day.





2. Personal debt in the UK

Total UK personal debt

People in the UK owed £1.484 trillion at the end of June 2016. This is up from £1.444 trillion at the end of June 2015 – an extra £777.90 per UK adult.

The average total debt per household – including mortgages – was £54,952 in June. The revised figure for May was £54,761.

Per adult in the UK that's an average debt of £29,379 in June – around 112.2% of average earnings. This is slightly up from a revised £29,203 a month earlier.

Based on June2016 trends, the UK's total interest repayments on personal debt over a 12 month period would have been £52.483 billion.

- That's an average of £144 million per day.
- This means that households in the UK would have paid an average of £1,944 in annual interest repayments. Per person that's £1,039 3.97% of average earnings.

According to the Office for Budget Responsibility's July 2015 forecast, household debt is predicted to reach £2.551 trillion in Q1 2021. This makes the average household debt £94,481 (assuming that the number of households in the UK remained the same between now and Q1 2021).

Consumer credit debt

Outstanding consumer credit lending was £186 billion at the end of June 2016.

 This is up from £176.1 billion at the end of June 2015, and is an increase of £195.76 for every adult in the UK.

Per household, that's an average consumer credit debt of £6,889 in June, up from a revised £6,833 in May - or £366.15 extra per household over the year.

It also means the average consumer credit borrowing stood at £3,683 per UK adult. This is up from a revised £3,653 in May.

Total credit card debt in June 2016 was £65.2bn. Per household this is £2,413 – for a credit card bearing the average interest, it would take 25 years and 6 months to repay if you made only the minimum repayment each month.

• The minimum repayment in the first month would be £58 but reduces each month. If you paid £58 every month, the debt would be cleared in around 5 years and 4 months.







Net lending and write-offs

Total net lending to individuals by UK banks and building societies **rose by £5.2 billion** in June 2016 – or £173m a day.

- Net mortgage lending rose by £3.3 billion in the month; net consumer credit lending rose by £1.9 billion.
- In Q1 itself they wrote off £624 million (of which £320 million was credit card debt) amounting to a daily write-off of £6.9 million.

2. Personal debt in the UK

Student loans

In 2014/15, the average maintenance loan awarded for full-time undergraduates from England was £3,890, and the average maintenance grant awarded to successful applicants was £3,008.

The average debt owed per student at the end of 2013/14 was £12,651 (this is debt for English students and EU students in England, including loans for Further and Higher Education. It doesn't include 'mortgage-style' loans, as these were sold by Government in May 2013).

The average debt for the 2016 cohort which most recently entered repayment was £24,640. – this is the last group who will not have paid £9,000 tuition fees.

Advice, insolvency, and the courts

Citizens Advice Bureaux across England and Wales dealt with **597,216** new enquiries in the three months between January and March 2016.

Debt was the second largest advice category (behind Benefits) with 409,000 issues. This is a 3% decrease on the same period last year. Debt issues represented 27% of all problems dealt with over the period.

Based on *quarterly* figures up to the end of March 2016, Citizens Advice Bureaux in England and Wales are dealing with **4,495** debt problems every *working day*.

 CAB cite the loss of legal aid and falling trends in many individual debt types for the reduction in debt advice cases.

There were **22,503** individual insolvencies in England and Wales in Q2 2016. This is equivalent to **247** people a day or, one person **every 5 minutes 49 seconds**. This was up **6.9%** on the previous quarter and up **22.4%** on the same period a year ago.

Every day, on average, **39** people were made bankrupt, **74** Debt Relief Orders were granted, and **134** Individual Voluntary Arrangements were entered into.

In the 12 months ending Q1 2016, 1 in 541 adults (just under 0.18% of the adult population) became insolvent. This was the lowest rate in a decade.

2,102 Consumer County Court Judgements (CCJs) were issued every day in the year to Q4 2015.

The average value of a Consumer CCJ in Q4 2015 was £2,030.

Mortgage debt

Outstanding mortgage lending stood at £1.298 trillion at the end of June.

This is up from £1.268 trillion a year earlier.

That means that the estimated average outstanding mortgage for the 11.1m households with mortgage debt was £117,162 in June.

The average mortgage Interest rate was 2.89% at the end of June. Based on this, households with mortgages would pay an average of £3,386 in mortgage interest over the year.

For new loans, the average mortgage Interest rate was 2.41%. Using the latest figures from the Council of Mortgage Lenders, this means new mortgages would attract an average of £3,768 in interest over the year.

According to the Council of Mortgage Lenders, gross mortgage lending in June totalled an estimated £20.7 billion.

• This is 3% higher than June 2015, and up 16% up on May.

The Financial Conduct Authority reports that 68.34% of mortgage lending in Q1 2016 was for 75% or less of a property's value.

2.72 % of lending was for mortgages for over 90% of a property's value.


There were 40,103 loans approved for house purchase in June, according to the British Bankers Association (BBA), almost unchanged from a year earlier. The average loan approved for house purchase rose to £184,400.



House prices

Nationwide estimate that house prices rose by 0.2% during June 2016, and were up 5.1% on 12 months ago.

Halifax said that house prices rose by £2,819 in May 2016. This is a monthly rise of 1.3%; prices rose 1.2% over the quarter and 8.4% over the year.

First-time buyers

The Office of National Statistics say that the average house price for first-time buyers was £220,000 in March 2016, which is an annual increase of 8%.

According to the Council of Mortgage Lenders (CML), the typical first-time buyer deposit in May was 15.4% (around £28,284) – 109% of an average salary.

The average first-time buyer borrowed **3.37** times their income and the average first-time buyer loan was an estimated **£131,000**.





Renting

The median rent in England across all property types for the 12 months to March 2016 was £650, data from the Valuation Office Agency shows. In London this was £1,452.

For a single room, the average monthly rent was £360 – in London this was £585 (63% higher).

The average monthly rent for a two-bedroom house in England was £600 – in London this was £1,500 (150% higher).

According to the Office for National Statistics, private rental prices in Great Britain rose by 2.4% in the 12 months to June 2016.

Rental prices increased in all the English regions over the year to June 2016, with the South East seeing the biggest increase (3.4%) and the North East seeing the lowest rise (0.8%).

Figures from DCLG show that in 2014/15, private renters spent an average of £775.67 a month on rental payments, while owner-occupiers paid £663 in mortgage payments.

• These figures are the mean payments, so can be skewed by very high figures.

Inclusive of all benefits, private renters spent an average of 43% of their income on rental payments. Owner-occupiers spent on average 19%. Weekly rents in the social housing sector were £98 for housing association renters and £89 for local authority renters.

33% of households owned their home outright, while 30% were mortgagors. 19% rent privately, and 17% pay a social rent.

- 2012/13 was the first year ever there outright owners where the largest tenure group.
- The rate of private renting is the highest it has been since the 1960s.



Arrears and repossessions

According to the Financial Conduct Authority, at the end of Q1 2016 there were **207,052** mortgage loan accounts with arrears of more than 1.5% of the current loan balance.

• This is 8% up on the previous quarter.

60.36% of payments due for loans in arrears were received in Q1 2016.

The Council of Mortgage Lenders reports that **96,200 (0.86%)** of mortgages had arrears equivalent to at least 2.5% of the outstanding mortgage balance in Q1 2016 – the lowest since 2006. Since the end of Q4 2014, this figure has dropped by **41** a day.

The Council of Mortgage Lenders estimates that **6,600 owner-occupied** properties were taken into possession in the year to March 2016.

This equates to 18 properties being repossessed every day, or one property being repossessed every one hour, 19 minutes 40 seconds.

Every day in Q1 2016, 53 mortgage possession claims were issued and 36 mortgage possession orders were made.

423 landlord possession claims were issued and 323 landlord possession orders were made every day.



4. Savings and pensions

Savings

In Q1 2016, households saved an average of **5.9%** of their post-tax income, including benefits, over the full year of 2015 this was **6.1%**.

The average interest rate for an instant access savings account – not including bonus interest payments – was 0.3% in June. For a cash ISA, this was 0.67%.

If someone on the average salary saved 5.9% of their income in an average instant access savings account for a year, they would receive £3.67 in interest after tax. If they saved it in an average cash ISA, they would receive £10.24.

It would take 18 years for someone on the average salary, saving the average amount per household every year in an average instant access savings account, to afford the average first-time buyer deposit. If they saved into a cash ISA at the same rate it would take 17 years.

Around 9.45m (35%) households have no savings, while a further 2.97m (11%) have under £1,500. 68% have less than £10,000 in savings.

Pensions

The Pensions Regulator estimates that at least **6.411 million** employees had joined a pension scheme under auto-enrolment by the end of June 2016.

According to the Family Resources Survey, **42%** of adults actively participated in a pension in 2014/15, up **5%** on the previous year. This was **60%** for employees, and **16%** for the self-employed.

The Annual Survey of Hours and Earnings reports that **59.2%** of employees were receiving an employer contribution to their pension.

28% of employees were in a Defined Benefit scheme in 2012, according to the Office for National Statistics.

In 2008/10, the average value of a Defined Contribution pot was £29,000.

At the end of November 2015, there were 12.97 million claimants of State Pension, a fall of 12,000 on a year earlier. 43% of claimants were male and 57% female.





5. Spending and loans

How we spend

During April 2016 an average of 461 purchases were made in the UK every second using debit and credit cards, based on figures from the UK Cards Association.

- An average of £20,448 was spent every second using debit and credit cards.
- Purchases using plastic cards were worth £1.77 billion every day during April.
- In total, 106 purchases using credit cards were made every second, worth £5,826.

Meanwhile, data from LINK shows that, on average, 102 cash machine transactions (including balance enquiries and rejected transactions) were made every second in June 2016.

- In total, cash machine transactions were worth an average of £4,133 per second.
- LINK's transaction figures do not include transactions or withdrawals made by customers at their own bank's or building societies' ATMs.

What we buy

In Q1 2016, households in the UK spent £91.70m a day on water, electricity and gas – or £3.40 per household per day.

In June 2015 the average price of unleaded petrol rose by 2.4 ppl (pence per litre) to 111.58ppl.

- This meant it cost £55.79 to fill a 50 litre unleaded tank.
- The average price of diesel jumped by 2.2ppl to 109.1ppl.

According to the AA, it costs **51.60 pence per mile** to run a car. This is based on buying a new petrol car for between £13,000 and £18,000, replacing it after 4 years, and averaging 10,000 miles per year.

- Do 30,000 miles per year in a car that cost less than £13,000 and the cost falls to 25.46ppm
- Do 5,000 miles per year and spend £25,000 £32,000 on the vehicle and the cost soars to 126.04ppm.

LV's 'Cost of a Child' report estimates that parents now spend a record £231,843 on raising a child to their 21st birthday - £30.23 a day. This is up 1.1% compared to last year, and has increased 65.1% since the study first began in 2003.

- Education and childcare are the main areas of expenditure, costing £74,430 and £70,466.
- The cost of education (including uniforms, after-school clubs and university costs) has increased 128% since 2003, while the cost of childcare has risen by 77.9%.
- · Households now spend 38% of their annual income on raising a child.






5. Spending and loans

The cost of credit

The average interest rate on credit card lending bearing interest was **18.42%** in April. This is **17.92%** above the Bank of England Base Rate (0.5%).

British Bankers Association figures show that 57.1% of credit card balances were bearing interest in June 2016.

The average APR for a £5,000 personal loan is 9.24%, according to the Bank of England. For a £10,000 loan it's 4.28%, while the average rate for an overdraft is 19.68%.

6. The bigger picture

The UK economy **grew by 0.6%** in the second quarter of 2016, according to latest estimates from the Office of National Statistics.

CPI (Consumer Prices Index) annual inflation stood at **0.5%** in the year to June, unchanged from April.

In the three months to May 2016 pay including bonuses was up by 2.2% from a year ago, and pay excluding bonuses also rose by 2.0%. Average weekly pay was £502, or £471 excluding bonuses – an annual salary of £26,104, or £24,492 without bonuses.

The Bank of England Base Rate is currently set at **0.5%** (since being established in 1694, the Rate has never been lower). It was reduced to this level on 5th March 2009, and has been held there for 86 months.

Public Sector Net Borrowing (excluding public sector banks) was £7.8bn in June 2016, meaning that the Government spent an average of £260m per day more than it spent during the month (equivalent to £2,009 per second).

Public sector net debt *excluding* public sector banks was £1,620.7bn (84% of GDP). This was £1573.1bn at the end of June 2015, meaning public sector net debt grew by £128m a day in the year to April 2016.

According to the March 2016 Budget analysis from the Office for Budget Responsibility, public sector net debt is forecast to have peaked at **83.7% of GDP** in 2015-16, before falling to **74.7% of GDP** in 2020-21.

The population of the UK grew by an estimated 1,286 people a day between 2005 and 2015.



6. The bigger picture

An estimated 4.61 million people will fall into the 40% income tax band in 2015/16 - 1.39m more than in 2010/11. 347,000 will pay the 45% rate, which replaced the 50% rate in 2013/14.

Based on the latest figures, 2.116m people in work would pay no income tax.

There were **4.726 million** working-age people claiming benefits in November 2015. This is a decrease of 249,530 in the year, or **684 a day**.

The number of people classed as unemployed between March to May was **1.646 million** (5%). This is down by 54,000 from the previous three months, and down by 201,000 from a year earlier – 550 a day.

• **461,000** people had been unemployed for over 12 months, down by 7,000 from the previous three months, and down by 110,000 (301 a day) from a year earlier.

The unemployment rate in Great Britain was highest in the North East (7.4%) and lowest in the East of England (3.5%).

475,000 18-24 year olds (11.6%) were unemployed between March and May. This was 25,000 (5.3%) fewer than the previous three months.

- Of these, **165,000** (35%) had been unemployed for over 6 months.
- **92,000** had been unemployed for over 12 months. This is 7,000 down on the previous three months and a fall of 47,000 on a year earlier.

916,000 18 to 24-year-olds in England were not in education, employment or training (NEET), down 31,000 from the previous quarter.

325,000 people aged over 50 were unemployed between March and May. This is down 3% from the previous three months, but up 3% on a year earlier.

- 43% of unemployed workers aged over 50 a total of 142,000 people have been out of work for over a year. 92,000 have been unemployed for more than two years.
- **1,206,000** (10.6%) people aged over 65 were *in work*, which is up 35,000 (2.9%) from the previous three months, and 75,000 (6.2%) from the previous year.

104,000 people **(1,130 a day)** reported they had become redundant over the three months, down 1000 a day from the previous quarter.
