

KS4 Money Workshops (100 Minutes)

Our **Key Stage 4 Money Workshops** are aimed at secondary school students aged 14 – 16. They are delivered by our externally trained workshop consultants.

Our workshops provide students with the practical knowledge and skills they need to manage their finances now and in the future. Each workshop includes a range of activities, the chance to debate and discuss, and relevant takeaways for the students.

We offer three standard 100 minutes long workshops for Key Stage 4; these are the KS4 1, 2 and 3 Money Workshops. We also offer five standard 60 minute workshops; please refer to “KS4 Money Workshops (60 minutes)” for further details.

KS4X Money Workshop

Our KS41 Money workshop helps students understand the importance of planning ahead with their finances, in particular it covers:

- Setting long term and short term goals;
- Putting financial plans in place to help you achieve your goals;
- Tax and National Insurance.



The KS4Y Money Workshop

Our KS42 Money Workshop builds on the content from the previous workshops and helps students understand the difference between saving and credit, in particular it covers:

- Understanding what credit is, where you can get it and what APR stands for;
- The importance of saving – understanding AER and choosing a savings account;
- Understanding what insurance is and how to get it



The KS4Z Money Workshop

Our KS42 Money Workshop builds on the content from the previous workshops and helps students understand financial products and how they work, in particular it covers:

- Pensions – What they are and why they are important.
- Mortgages – What you need to save and how they work.

We can also create tailor made workshop, depending on a schools’ needs and requirements.

We understand that teachers require engaging, flexible and time efficient ways to deliver financial education to their students. We pride ourselves on providing high quality support to schools by ensuring our workshops fit into school timetables and requirements. We typically deliver as part of designated lesson times, such as Citizenship, Maths or PSHE.

In 2013 we delivered 1,104 workshops to 29,265 students across England, Wales and Northern Ireland.

Our evaluation data is externally managed and collected before and after each of our workshops to allow us to effectively measure the impact of workshops on student's skills, knowledge and confidence related to managing money.

In terms of skills gained after the workshop, our data shows:

- Before the workshop only 32% of students were confident they could create a budget – this doubled post workshop, to 68%.
- Before the workshop only 1 in 10 students felt confident they could explain the pros and cons of different types of credit. This rose to 6 in 10 after the workshop.
- Before the workshop only 36% of students felt confident they knew the difference between their 'priority' and 'non-priority' costs – after the workshop this rose significantly to 77% feeling confident.
