# 1. Striking numbers

### **Every day in the UK**

- The population of the UK grew by an estimated 1,223 people a day between 2003 and 2013.
- On average, a UK household spends £3.10 a day on water, electricity and gas, up from £2.91 in Q4 2014
- 206 people a day are declared insolvent or bankrupt. This is equivalent to one person every 6
  minutes 53 seconds.
- 36 million plastic card purchase transactions were made every day in May 2015, with a total value of £1.7 billion.
- 8.9m cash machine transactions were made every day in June with a value of £355m.
- 2,330 Consumer County Court Judgements (CCJs) are issued every day, with an average value of £2,171.
- Citizens Advice Bureaux in England and Wales dealt with 6,323 new debt problems every working day during the year ending March 2015.
- 48 properties are repossessed every day, or one every 29 min 42 seconds.
- The number of mortgages with arrears of over 2.5% of the remaining balance fell by 67 a day.
- The number of people unemployed for over 12 months fell by 504 per day.
- 1,311 people a day reported they had become redundant between March and May.
- Government borrowed £313m a day during June 2015 (£3,636 per second).
- Net lending to individuals in the UK increased by £109m a day.
- Borrowers would repay £147m a day in interest over a year, based on June 2015 trends.
- It costs an average of £29.91 per day to raise a child from birth to the age of 21.
- 63 mortgage possession claims and 47 mortgage possession orders are made every day.
- 469 landlord possession claims and 349 landlord possession orders are made every day.





### 2. Personal debt in the UK

### **Total UK personal debt**

People in the UK owed £1.441 trillion at the end of June 2015. This is up from £1.409 trillion at the end of June 2014 – an extra £628 per UK adult.

The average total debt per household – including mortgages – was £53,961 in June. The revised figure for May was £53,838.

Per adult in the UK that's an average debt of £28,532 in June – around 111.2% of average earnings. This is up from a revised £28,467 in May.

Based on June 2015 trends, the UK's total interest repayments on personal debt over a 12 month period would have been £53.497 billion.

- That's an average of £147 million per day.
- This means that households in the UK would have paid an average of £2,003 in annual interest repayments. Per person that's £1,059 4.13% of average earnings.

According to the Office for Budget Responsibility's July 2015 forecast, household debt is predicted to reach £2.551 trillion in Q1 2021. This makes the average household debt £95,532 (assuming that the number of households in the UK remained the same between now and Q1 2021).

#### Consumer credit debt

Outstanding consumer credit lending was £172.34 billion at the end of June 2015.

 This is up from £161.1 billion at the end of June 2014, and is an increase of £222.17 for every adult in the UK.

Per household, that's an average consumer credit debt of £6,454 in June, up from a revised £6,427 in May - or £420 extra per household over the year.

It also means the average consumer credit borrowing stood at £3,413 per UK adult in June. This is up from a revised £3,398 in May.

Total credit card debt in June 2015 was £61.8bn. Per household this is £2,314 – for a credit card bearing the average interest, it would take 25 years and 4 months to repay if you made only the minimum repayment each month.

• The minimum repayment in the first month would be £55 but reduces each month. If you paid £55 every month, the debt would be cleared in around 5 years and 4 months.


### Net lending and write-offs

Total net lending to individuals by UK banks and building societies **rose by £3.8 billion** in June 2015 – or £127m a day.

Net mortgage lending rose by £2.6 billion in the month; net consumer credit lending rose by £1.3 billion.

UK Banks and Building Societies **wrote off £3.163 billion** of loans to individuals over the four quarters to Q1 2015.

• In Q1 2015 itself they wrote off £822 million (of which £317 million was credit card debt) amounting to a daily write-off of £9.1 million.

### 2. Personal debt in the UK

#### Student loans

In 2013/14, the average Maintenance Loan awarded for full-time undergraduates from England was £3,842, and the average Maintenance Grant awarded to successful applicants was £2,778.

The average debt owed per student at the end of 2013/14 was £12,651 (this is debt for English students and EU students in England, including loans for Further and Higher Education. It doesn't include 'mortgage-style' loans, as these were sold by Government in May 2013).

The average debt for the 2014 cohort which just entered repayment was £20,100.

### Advice, insolvency, and the courts

Citizens Advice Bureaux across England and Wales dealt with **588,000** new enquiries in the three months between January and March 2015.

Debt was the second largest advice category (behind Benefits) with 421,647 issues. This is a 3% decrease on the same period last year. Debt issues represented 28% of all problems dealt with between January and March 2015.

Based on *annual* figures up to the end of March 2015, Citizens Advice Bureaux in England and Wales are dealing with **6,323** debt problems every *working day*.

 CAB cite the loss of legal aid and falling trends in many individual debt types for the reduction in debt advice cases.

There were **19,008** individual insolvencies in England and Wales in Q2 2015. This is equivalent to **209** people a day or, one person **every 6 minutes 53 seconds**. This was a fall of **6.5%** on the previous quarter and **29.5%** on the same period a year ago.

Every day, on average, **44** people were made bankrupt, **64** Debt Relief Orders were granted, and **101** Individual Voluntary Arrangements were entered into.

In the 12 months ending Q2 2015, 1 in 589 adults (just over 0.17% of the adult population) became insolvent. This was the lowest rate in a decade.

2,330 Consumer County Court Judgements (CCJs) were issued every day in Q1 2015. The average value of a Consumer CCJ in Q1 2015 was £2,171.

### Mortgage debt

Outstanding mortgage lending stood at £1.269 trillion at the end of June.

This is up from £1.248 trillion at the end of June 2014.

That means that the estimated average outstanding mortgage for the 11.1m households with mortgage debt was £114,535 in May.

The average Mortgage Interest rate was 3.09% at the end of June. Based on this, households with mortgages would pay an average of £3,539 in mortgage interest over the year.

For new loans, the average Mortgage Interest rate was 2.56%. Using the latest figures from the Council of Mortgage Lenders, this means new mortgages would attract an average of £3,214 in interest over the year.

According to the Council of Mortgage Lenders, gross mortgage lending in June totalled an estimated £20.5 billion.

• This is 15% higher than June 2014, and 29% up on May 2015.

The Financial Conduct Authority reports that 67.6% of mortgage lending in Q1 2015 was for 75% or less of a property's value.

• 3.3% of lending was for mortgages for over 90% of a property's value.


There were 53,642 loans approved for house purchase in June, according to the British Bankers Association (BBA), 10% higher than a year earlier. The average loan approved for house purchase rose to £176,200.



#### **House prices**

Nationwide estimate that house prices fell by 0.2% during June 2015, but were up 3.3% on May 2014.

Halifax said that house prices rose by £3,414 in June 2015. This is a monthly decrease of 1.7%; prices rose 3.3% over the quarter and 9.6% over the year.

### First-time buyers

The Office of National Statistics say that the average house price for first-time buyers was £211,000 in April 2015, which is an annual increase of 5.1%.

According to the Council of Mortgage Lenders (CML), the typical first-time buyer deposit in April was 19% (around £23,443) – 91% of an average salary.

The average first-time buyer borrowed **3.34** times their income and the average first-time buyer loan was an estimated £126,035.





### Renting

The median rent in England across all property types for the 12 months to March 2015 was £600, data from the Valuation Office Agency shows. In London this was £1,350.

For a single room, the average monthly rent was £347 – in London this was £525 (51% higher).

The average monthly rent for a two-bedroom house in England was £595 – in London this was £1,400 (135% higher).

According to the Office for National Statistics, private rental prices in Great Britain rose by 2.1% in the 12 months to March 2015.

Rental prices increased in all the English regions over the year to March 2015, with London seeing the biggest increase (3.2%).

Respondents to the May 2015 RICS survey expected rents to rise by 5% per year over the next five years.

Figures from DCLG show that in 2013/14, private renters spent an average of £762.67 a month on rental payments, while owner-occupiers paid £663 in mortgage payments.

• These figures are the mean payments, so can be skewed by very high figures.

Inclusive of all benefits, private renters spent an average of 43% of their income on rental payments. Owner-occupiers spent on average 19%. Weekly rents in the social housing sector were £98 for housing association renters and £89 for local authority renters.

33% of households owned their how outright, while 31% were mortgagers. 19% rent privately, and 17% pay a social rent.

- 2012/13 was the first year ever there outright owners where the largest tenure group.
- The rate of private renting is the highest it has been since the 1960s.





### Arrears and repossessions

According to the Financial Conduct Authority, at the end of Q1 2015 there were **212,140** mortgage loan accounts with arrears of more than 1.5% of the current loan balance. This is 3.5% down on the previous quarter, and the lowest figure since records began in 2007.

Loans in arrears represented 1.56% of the value of the residential loan book.

62.92% of payments due for loans in arrears were received in Q4 2014.

The Council of Mortgage Lenders reports that **113,900 (1.03%)** of mortgages had arrears equivalent to at least 2.5% of the outstanding mortgage balance – the lowest since 2006. Since the end of Q1 2014, this figure has dropped by **67** a day.

The Council of Mortgage Lenders estimates that **17,700** properties were taken into possession in the year to March 2015.

This equates to 48 properties being repossessed every day, or one property being repossessed every 29 minutes 42 seconds.

Every day in Q1 2015, 63 mortgage possession claims were issued and 47 mortgage possession orders were made.

**469** landlord possession claims were issued and **349** landlord possession orders were made every day.



# 4. Savings and pensions

### Savings

In Q1 2015, households saved an average of **4.9%** of their post-tax income, including benefits, the lowest figure since Q3 2008.

The average interest rate for an instant access savings account – not including bonus interest payments – was 0.38% in April. For a cash ISA, this was 0.86%.

If someone on the average salary saved 4.9% of their income in an average instant access savings account for a year, they would receive £3.82 in interest after tax.

If they saved it in an average cash ISA, they would receive £10.81.

It would take 19 years for someone on the average salary, saving the average amount per household every year in an average instant access savings account, to afford the average first-time buyer deposit. If they saved into a cash ISA at the same rate it would take 18 years.

Around 9.24m (35%) households have no savings, while a further 3.43m (13%) have under £1,500.

#### **Pensions**

The Pensions Regulator estimates that at least **5.286 million** employees had joined a pension scheme under auto-enrolment by the end of June 2015.

According to the Family Resources Survey, **30%** of adults actively participated in a pension in 2013/14, up **4%** on the previous year. This was **52%** for employees, and **17%** for the self-employed.

The Annual Survey of Hours and Earnings reports that **59.2%** of employees were receiving an employer contribution to their pension.

**28%** of employees were in a Defined Benefit scheme in 2012, according to the Office for National Statistics.

In 2008/10, the average value of a Defined Contribution pot was £29,000.

At November 2014, there were 13 million claimants of State Pension, a rise of 68,000 on a year earlier. 42% of claimants were male and 58% female.





# 5. Spending and loans

### How we spend

During May 2015 an average of 422 purchases were made in the UK every second using debit and credit cards, based on figures from the UK Cards Association.

- An average of £19,715 was spent every second using debit and credit cards.
- Purchases using plastic cards were worth £1.7 billion every day during May.
- In total, 98 purchases using credit cards were made every second, worth £5,633.

Meanwhile, data from LINK shows that, on average, 103 cash machine transactions (including balance enquiries and rejected transactions) were made every second in June 2015.

- In total, cash machine transactions were worth an average of £4,112 per second in June.
- LINK's transaction figures do not include transactions or withdrawals made by customers at their own bank's or building societies' ATMs.

### What we buy

In Q1 2015, households in the UK spent £82.80m a day on water, electricity and gas – or £3.10 per household per day.

In July 2015 the average price of unleaded petrol rose by 0.05ppl (pence per litre) to 117.24ppl.

- This meant it cost £58.62 to fill a 50 litre unleaded tank.
- The average price of diesel rose by 1.67ppl to 119.33ppl.
- The cheapest unleaded petrol in the UK was 116.9ppl, found in Wales.

According to the AA, it costs **51.60 pence per mile** to run a car. This is based on buying a new petrol car for between £13,000 and £18,000, replacing it after 4 years, and averaging 10,000 miles per year.

- Do 30,000 miles per year in a car that cost less than £13,000 and the cost falls to 25.46ppm
- Do 5,000 miles per year and spend £25,000 £32,000 on the vehicle and the cost soars to 126.04ppm.

LV's 'Cost of a Child' report estimates that parents now spend a record £229,251 on raising a child to their 21<sup>st</sup> birthday - £29.91 a day. This is up 0.9% compared to last year, and has increased 63.3% since the study first began in 2003.

- Education and childcare are the main areas of expenditure, costing £74,319 and £67,586.
- The cost of education (including uniforms, after-school clubs and university costs) has increased 128% since 2003, while the cost of childcare has risen by 70.6%.
- Parents now spend 29% of their annual income on raising a child.






# 5. Spending and loans

#### The cost of credit

The average interest rate on credit card lending bearing interest was **18.14%** in June. This is **17.64%** above the Bank of England Base Rate (0.5%).

British Bankers Association figures show that 58.4% of credit card balances were bearing interest in June 2015.

The average APR for a £5,000 personal loan is 8.82%, according to the Bank of England. For a £10,000 loan it's 4.28%, while the average rate for an overdraft is 19.67%

# 6. The bigger picture

The UK economy **grew by 0.7%** in the Second quarter of 2015, according to latest estimates from the Office of National Statistics.

CPI (Consumer Prices Index) annual inflation stood at 0% in June, down from 0.1% in May.

In the three months to May 2015 pay including bonuses was up by 3.2% from a year ago, and pay excluding bonuses also rose by 2.8%. Average weekly pay was £492, or £462 excluding bonuses – an annual salary of £25,584, or £24,090 without bonuses.

The Bank of England Base Rate is currently set at **0.5%** (since being established in 1694, the Rate has never been lower). It was reduced to this level on 5<sup>th</sup> March 2009, and has been held there for 76 months.

Public Sector Net Borrowing (excluding public sector banks) was £9.4bn in June 2015, meaning that the Government borrowed an average of £313m per day during the month (equivalent to £3,636 per second).

In June 2015, public sector net debt <u>excluding</u> public sector banks was £1513.4bn (81.5% of GDP). This was £1436bn (80.1% of GDP) at the end of June 2014, meaning public sector net debt grew by £212m a day in the year to June 2015.

Public sector net debt <u>including</u> public sector banks was £1825.6bn (98.3% of GDP). This was £1747.7bn (97.5% of GDP) at the end of June 2014.

• The Office of National Statistics includes complete data from the Royal Bank of Scotland and Lloyds Banking Group, which were part-nationalised in 2008, in its calculations for the figure that includes public sector banks.

According to the July 2015 Budget analysis from the Office for Budget Responsibility, public sector net debt is forecast to have peaked at **80.8% of GDP** in 2014-15, before falling to **71.5% of GDP** in 2019-20.

# 6. The bigger picture

An estimated 4.65 million people will fall into the 40% income tax band in 2015/16 – **1.08m** more than in 2011/12. 332,000 will pay the 45% rate, which replaced the 50% rate in 2013/14.

Based on the latest figures, 2.116m people in work would pay no income tax.

There were **5 million** working-age people claiming benefits in November 2014. This is a decrease of 318,000 in the year, or **871 a day**.

The number of people classed as unemployed between March and May was **1.85 million** (5.6%). This is up by 15,000 from the previous three months, but down by 273,000 from a year earlier – **748** a day.

• **570,000** people had been unemployed for over 12 months, down by 53,000 from the previous three months, and down by 184,000 (504 a day) from a year earlier.

The unemployment rate in Great Britain was highest in the North East (7.7%) and lowest in the South East (4.4%).

**579,000** 18-24 year olds (14.2%) were unemployed between March and May. This was 9,000 (1.6%) fewer than the previous three months.

- Of these, 231,000 (40.0%) had been unemployed for over 6 months.
- **140,000** had been unemployed for over 12 months. This is 40,000 (22%) lower than the previous three months and a fall of 52,000 (27.1%) on a year earlier.

At the end of Q1 2015, **943,000** of 18 to 24-year-olds in England were not in education, employment or training (NEET), down 45,000 from a year earlier.

**312,000** people aged over 50 were unemployed between March and May. This is up 3.4% from the previous three months, but down 18.1% on a year earlier.

- 40% of unemployed workers aged over 50 a total of 124,000 people have been out of work for over a year. 83,000 have been unemployed for more than two years.
- **1,149,000** (10.5%) people aged over 65 were *in work* between March and May, which is down 45,000 (3.8%) from the previous three months, but up 3,000 (0.3%) from the previous year.

**118,000** people **(1,311 a day)** reported they had become redundant over the three months, 8,000 up on the previous quarter.
